

# 2025 Assister Certification Training Modules

The CMS MLMS **Plan Year (PY) 2025 Assister Certification Training** opened September 6, 2024. In preparation for the Marketplace PY 2025 Open Enrollment Period, which begins November 1, 2024.

This training is hosted on the Marketplace Learning Management System (MLMS); the online webbased training platform for assisters providing application and enrollment assistance to consumers in Federally-Facilitated Marketplaces (FFMs) and State-based Marketplaces using the Federal platform. The MLMS can be accessed through the **CMS Enterprise Portal**.

## **New MLMS User Registration**

Steps to Register for CMS Secure Portal ID as a NEW User:

- 1. Select New User Registration
- 2. Select Federally Facilitated Marketplace application and Agree to the Terms and Conditions
- 3. Register Your Information
- 4. Create a unique User ID and Password
- 5. Choose a **Challenge Question** and **Answer**
- 6. Review Registration Summary
- 7. Set up Multi-Factor Authentication (MFA)

Once you've created an account, you need to request access to MLMS. Refer to these steps:

- 1. Login to CMS Secure Portal
- 2. Select Request/Add Apps
- 3. Search for FFM/Training
- 4. Select **Assister** Role

### **Existing MLMS Users Login HERE**

Since Illinois is considered a State Based Marketplace (SBM) on the Federal Platform (FP) —or a SBM-FP— this year, there are new instructions for how to sign into the trainings:

- When you log into the CMS Secure Portal you will choose the MLMS training.
- Once logged in you will be at a screen that will prompt you to choose 1 of 5 choices.
- You will check the box for **SBM-FP**.
- You will not put an ID in the box, simply click "Save."
- This will take you to the training page.

# Required ID Validation for MLMS Access

All **new** assisters (Certified Application Counselors (CACs), Navigators, and Enrollment Assistance Personnel (EAPs), and State Based Exchange-Federal Platform Assisters) will need to **verify their identity** on the CMS Portal to access Assister Certification Training on the MLMS. Plan Year 2025 FFM Assister Certification Training Guide provides an overview of how to register as a new assister using the Identity Verification process, or login as a returning assister. Please review the guide **prior** to taking training. **If you have taken Assister Certification Training in the past, and already have a CMS Portal account, please DO NOT create another account,** you should simply log in to access this year's training.
